

# Pertinent Issues

Research indicates prolonged incarceration and increased mental health symptoms are directly correlated; and in-patient care (in jails, hospitals, etc...) is more costly than community-based treatment.

Moreover, an increasing number of individuals with mental health treatment needs are identified during interactions with the criminal justice system. This growing problem is a national trend. One key in addressing this crisis is to identify people with a mental illness as early as possible in the criminal justice system. Once identified, the Diversion Program offers the Court viable alternatives to institutionalization and/or criminalization with careful consideration of mental health laws.

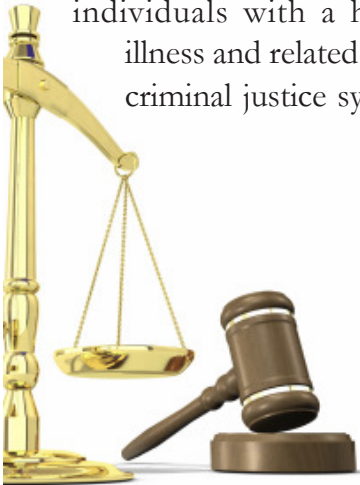

# Program Goals

## Lee Mental Health's Diversion Program strives to:

- ◆ Divert individuals with serious mental illnesses (including those with co-occurring substance abuse disorders) from unnecessary institutionalization and/or criminalization.
- ◆ Offer the Court viable alternatives to institutionalization and/or criminalization.
- ◆ Expedite resolution to legal matters complicated by issues related to mental illnesses.
- ◆ Reduce the risk of recidivism among individuals with a history of mental illness and related involvement in the criminal justice system.



# Program Description

The program is intended to divert individuals with serious mental illnesses (including persons with co-occurring substance abuse disorders) from unnecessary institutionalization and/or criminalization.

Specifically, this program is for individuals with criminal charges in which a severe and persistent mental illness may complicate the legal proceedings. In essence, the Diversion Program serves as a bridge between the legal and mental health systems.

Further, the Diversion Program can often assist the Criminal Justice System in understanding, identifying and managing cases where a mental health disorder may be present.

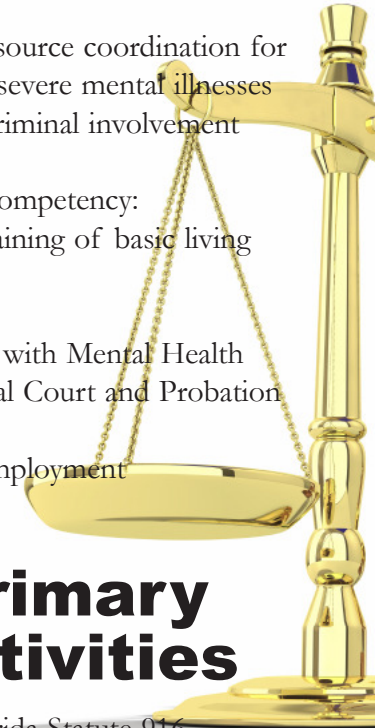

- ◆ Advocacy and support related to Florida Statute Chapter 916
- ◆ State-approved competency restoration training
- ◆ Specialized resource coordination for individuals with severe mental illnesses and history of criminal involvement
- ◆ Community competency: individualized training of basic living skills
- ◆ Collaboration with Mental Health Court, Traditional Court and Probation
